Pharmacy benefits managers (PBMs) are more than just middlemen that create and administer drug formularies on behalf of health insurers, self-insured employers, Medicaid and other payers. They are among the most powerful forces in

Where's my Stimate?

In July 2020 Ferring Pharmaceuticals halted manufacturing of the nasal spray Stimate®, a used to treat bleeds in mild hemophilia A and some types of von Willebrand disease. The suspension and subsequent recall were in response to a packaging seal issue that caused

evaporation, a potential hazard to patients who could be exposed to dangerously high concentrations of the product's active ingredient desmopressin acetate. Read NHF's article here to learn more.

Sub-Q Hemophilia B Therapy Fast-Tracked

Centessa Pharmaceuticals announced that the U.S. Food and Drug Administration (FDA) has granted Fast Track designation to SerpinPC, an investigational subcutaneously administered novel inhibitor of activated protein C (APC) being developed for the treatment of hemophilia B, with or without inhibitors, which may also be developed to prevent bleeding associated with other bleeding disorders. Good News from Pfizer

Pfizer announced that the pivotal Phase 3 BASIS clinical trial evaluating *marstacimab* has demonstrated statistically significant and clinically meaningful effects. Marstacimab, a novel, investigational anti-tissue factor pathway inhibitor (anti-TFPI) being studied for the treatment of hemophilia A or B for people without inhibitors to factor VIII or factor IX, was administered



weekly with flat (not weight-based) dosing in the trial as a subcutaneous 300 mg loading dose followed by 150 mg once weekly. For more info click here.

Just in Case You Haven't Heard...

- A central venous access device (CVAD) is an implanted medical device used for IV infusions without having to access a vein. CVADs include internal devices, called ports, and external devices, called central lines.
- **Anaphylaxis** is a severe, potentially life-threatening whole-body allergic reaction, sometimes occurring after a factor infusion. Although anaphylaxis is rare, people with hemophilia B with inhibitors are at significantly higher risk of anaphylaxis if infused with factor IX.
- **Acquired hemophilia** is a rare and life-threatening autoimmune disorder in which the immune system mistakenly attacks factor VIII. It's often triggered by an illness such as cancer, and usually occurs in the elderly and sometimes in post-partum women.
